" Deadline for Annual California Energy. " Commission February 1, 2007 is deadline for submittal of CEC Form. We have attached a blank Form to fill in the sales records of gas sale for each product such as: gasoline, diesel, & liquid propane.

" Deadline for AQMD/Carb Regulations. " Deadline for installing Phase II EVR Vapor Recovery System although is extended to April 1, 2009, we recommend starting evaluating your choices of conversion. Sooner you start, you save money on parts and construction cost.

Rule 461 Vapor Recovery Record Keeping

South Coast Air Quality Management district on daily basis enforces the compliance issues with Rule 461 record keeping. According to this regulation, each facility must perform the following tasks: 1) Conduct twice a year vapor recovery test (if monthly sales exceeds 100,000 gallons per month), 2) maintain the repair log, 3) maintain monthly sales record, 4) record of daily inspection, 5) record of certificate of training of rule 461. Upon visiting your site, please make sure that our AQMD compliance binder has all the update record on site. Please notify us if your facility receives a Notice of Order to Comply (NTC). If you don't attempt to correct the items listed in this type of notice, then this notice will turn into a Notice of Violation with \$\$ monetary penalties. Please send us a copy of NTC as soon as you receive such a notice. Our goal is to assist you to eliminate a potential NTC.

Temporary Closure VS. Permanent Closure of Waste Oil Tank

If your site has an underground waste oil tank that is not in- use and you have no intention of using it, you are required by law to remove it. But, if your are in doubt, you can file for a temporary closure for at least six months until you decide to either use it or remove it permanently. Prior to removal, please find out if you have registered your tank with *Board of Equalization*, and you are current in fuel tax fees, which is about 1.4 cent per gallon. The purpose of paying this fee is to protect your self from costly fees of investigation, remediation, and cleanup cost in the event of discovery of contamination. The above fee is paid toward State Cleanup Fund and you will be able to qualify for this fund, if your site becomes contaminated or incur an unauthorized release of petroleum Hydrocarbon such as gasoline, diesel, and waste oil.

NFPA 110, Diesel Fuel Standard For Emergency and Standby Generator Systems

" Fuel contamination is a major cause of premature shutdown for standby engine generator sets, fire pump engines and other diesel engine support functions. Contamination commences as soon as the storage tanks are filled and continues until the fuel is used. As the length of period increases, the probability for premature engine shut down due to either clogged filters, or excessive water entrainment, increases. If you have an underground or above ground storage tank and need to examine your tank for presence of water, need filtration, biocide treatment, or a four- stage maintenance program, please contact us."
